Face to face Blended Training on Environmental Management and Eco-entrepreneurship

09.09.2020 - 15.09.2020

The Faculty of Economics in Prilep, and the Agency for promotion of entrepreneurship of RNM, organized Face to face training provided by experts/trainers from academia and the business sector by using blended methods.

Actually, the purpose of this activity was to provide face-to-face training based on developed curricula in Eco-Innovation Entrepreneurship and Eco-Management using a developed Training Platform.

Despite the situation with Covid 19, by respecting the prevention measures, training for two groups was organized:

- the first for group of 15 students (5 days, 3 hours per day) and
- the second for 15 SMEs professionals and young entrepreneurs (5 days, 4 hours per day).

All attendees had the opportunity to become more familiar with the fields of environmental management and eco-entrepreneurship through 4 Modules run by appropriate experts as follows:

TM1. Environmental and Energy Economics – Cost Benefit Analysis - Environmental Finance and Accounting, provided by prof. Pece Nedanovski, PhD,Faculty of Economics Skopje, UKIM This training module establishes the need for action so as to move towards sustainable economic development, focusing on sustainable production, that is, the role of business. In the second part, the module presents some important tools that can be used by business and in particular, Cost-Benefits Analysis, and Environmental Accounting.

TM2. Environmental Management – Environmental Impact Assessment - Corporate Social Responsibility, provided by prof. Sasho Kjosev, PhD, Faculty of Economics Skopje, UKIM The aim of the second training module is to create specialized personnel at both the theoretical and practical level dealing with environmental aspects related to environmental legislation, development and implementation of environmental management systems, sustainable planning and implementation of environmental projects.

TM3. Eco-innovation and technology transfer, provided by Gordana Chelebikj, RIST NCE Expert, Zone EMENA, business sector expert.

The third training module examines the transition from traditional to eco-industry, emphasizing the use of certain tools such as Life Cycle Assessment (LCA), Multi-criteria impact assessment (MIA) and multi-actor multi-criteria (MAM). The module uses case studies focusing on sectors of bioeconomy (agriculture, forestry, fisheries, aquaculture, etc.).

TM4. From a green idea to a sustainable business, provided by Valentina Disoska, owner of small business, President of the Association of Business Woman, business sector expert.

The fourth training module focuses on providing the participants with the basic knowledge and skills needed to start exploring the potential of such an idea, by identifying their first potential market and customers.
